

Regulations for the use of the motorhome pitch of the city of Emmendingen

On 18.10.2022, the Municipal Council of the City of Emmendingen adopted the following usage regulations as bylaws on the basis of § 4 of the Municipal Code for Baden-Württemberg in the version of 24 July 2000 (GBl. p. 581), last amended by Article 2 of the Act of 2 December 2020 (GBl. p. 1095, 1098):

§ 1 Scope

1. The motorhome pitch near the open-air swimming pool over the Elz in Emmendingen is owned by the city of Emmendingen. It is used exclusively by visitors to the city of Emmendingen with motorhomes for short-term parking of a maximum duration of two nights or three days.
2. The usage regulations are binding for all persons staying on the site. By entering the facility, the users agree to be bound by these regulations.

§2 Transfer, use

1. Motorhomes which are roadworthy and authorised and equipped with a waste water tank may be temporarily parked on the pitch without prior notice.
2. The city of Emmendingen provides connections for water supply and sewage disposal for a fee.
3. The pitch is open all year round. There is no entitlement to continuous operation of the site.
4. Any kind of commercial activity on the site is prohibited.

§ 3 User charges

1. parking a motorhome costs € 10,00/day. The ticket must be purchased at the parking ticket machine and affixed in a clearly visible position or via another payment function provided by the City of Emmendingen..
2. a fee of € 1,00 per 100 litres is charged for the purchase of water.
3. the charge for sewage disposal is € 0,50 per 100 litres.

§ 4 Liability, damage

The use of the motorhome site is at the sole risk and responsibility of the user.

The City of Emmendingen shall not be liable for damage of any kind resulting from the use of the pitch, its supply and disposal facilities, weather conditions, force majeure or third parties.

§ 5

Parking space regulations

1. The parking or leaving behind of waste of any kind is prohibited.
2. The installation and use of aggregates is prohibited.
3. The bringing along of dogs is permitted. Dog excrement must be disposed of in the containers provided on the pitch. There is a leash obligation.
4. The regulations of the police regulation of the city of Emmendingen apply.

§ 6

Misdemeanors

1. acts contrary to regulations in the sense of § 142 (1) No. 1 of the municipal code (GemO), who deliberately or negligently
 - a. The motorhome is not only parked at short notice within the meaning of § 1 No. 1.
 - b. violates the usage regulation according to § 2 No. 1 and 4
 - c. contravenes the parking space regulations according to § 5 No. 1, 2 and 3.
2. administrative offences can be punished according to § 142 Abs. 2 GemO i. V. m. § 17 Abs. 1 OwiG with a fine of five to one thousand Euro.
3. In the event of violations of these regulations, the City of Emmendingen may prohibit the use of the motorhome parking space.
4. The user is obliged to immediately evacuate at the request of the city. If he does not comply with this obligation, the city is entitled to have the eviction carried out. The user shall bear the costs incurred in this connection.

§ 7

Coming into effect

This user regulation shall enter into force on 1 January 2023. At the same time, the Regulations for Use of 1 October 2019 shall cease to apply.

Notes:

A possible violation of procedural or formal provisions of the Gemeindeordnung für Baden-Württemberg (GemO) or on the basis of the Gemeindeordnung when these statutes come into being shall be irrelevant pursuant to § 4 (4) GemO if it has not been asserted in writing to the city within one year of the announcement of these statutes; the facts which are to justify the violation shall be specified. This shall not apply if the provisions concerning the publicity of the meeting, the approval or the publication of the statutes have been violated.
